EXPLANATORY NOTE TO THE READER

This submission comprises a number of publications supported by a body of empirical evidence. The publications and outputs have been organised and coded for ease of reference and to support the narrative as follows:

- Key published works that represent steps of synthesis in research and practice in the form of books, book chapters and refereed papers. These are termed 'principal publications', coded as PP01–PP25 and listed at Annex 01; and
- A number of 'supporting publications' that provide a published record of individual cases from empirical research coded as SP01–SP15 and listed at Annex 02.

Taken together, the publications draw on an extensive body of work assembled over a number of years. This body of work represents the empirical evidence and database upon which the principal and supporting publications are founded. A catalogue is provided at Annex 06. This catalogue includes to a wide range of outputs permitted by the Degree Regulations.

To assist the reader, right-hand pages in the critical synthesis have been reserved for the text. Left-hand pages have been used for footnotes or left blank.

The list of publications in Annexes 01 and 02 follows the order of their citation in the text in the critical synthesis (Vancouver convention). As a consequence these lists are not in chronological order. Any citation of works listed in the bibliography follows the Chicago convention i.e. (author, date).

The declaration of authorship is included at Annex 03, a bibliography at Annex 04 and a curriculum vitae at Annex 05.

This critical synthesis and the annexes together constitute Volume 1 of the submission. The principal publications constitute Volume 2 (a bound volume of journal articles and individual copies of books). The supporting publications constitute Volume 3 (a bound volume of articles and a DVD of films).

ABSTRACT

ABSTRACT

Urbanism is the pursuit of urbanity. The work described in this submission contends that urbanity can be achieved by design through the application of three meta-principles. The fundamental aim underlying the published work concerns the (re-)introduction of design methods and practice into urbanism. A series of research questions examine methods, test these in practice, evidence trends, and document the contribution of the work. The work represents a systematic enquiry by design.

The critical synthesis is concerned with narrating an enquiry into design-based urbanism documented in a series of publications. It is a reflective review that discerns patterns and a convergence of thought and intent around the three meta-principles. The research described is longitudinal extending over a period of 25 years. It is also situational and scalar and has been undertaken in different contexts and across different scales from the singular designed artifact (a public space) through to city-regional planning.

In the 1950s, the cities of Western Europe and North America required extensive redevelopment. In general, the theories and principles of modernism were deployed to bring this about with the benefits of a systemic, readily replicable and relatively inexpensive process. By the 1960s there was disquiet that this approach led to the unacceptable loss of heritage and community.

Drawing on the extensive literature, emphasis is placed on the establishment of methods to translate the conceptual understanding of city building into practice in order to re-purpose the processes of urbanism. Eight propositions were used to inform methods for application in practice, testing in the studio and refinement in research for national agencies. The propositions are applied and tested in a range of case studies documented in the publications and considered in the light of thinking in empiricism, rationalism and pragmatism.

The publications examine casework in Glasgow, Newcastle-upon-Tyne, Sheffield and Moscow; a range of smaller towns and cities; public spaces and the creation of new urban contexts internationally. The work in practice is shadowed by pedagogic examination in the studio of the architectural academy.

Two principal conclusions are drawn: the tools and techniques have proved sufficiently robust to endure over time and in different contexts; and they have proved flexible and able to adapt as their relative importance has changed to reflect society's demands.

The design practice described in the publications has acted as the laboratory for developing and testing methods for carrying out urbanism by design. It is concluded that whereas approaches based on empirical, rational and pragmatic thought are necessary for intervention in the city, none is by itself sufficient.

The search for a comprehensive approach requires a balanced and integrated approach where the weight afforded to different methods is contingent on the circumstances and the context of their application and can be guided by a small number of overarching meta-principles providing unifying themes expressed as: (1) Learning from place (physical, cultural and human – combining the historical evolution of place and the evolution of the culture); (2) Designing with nature (ensuring the aesthetics and ecology of the ecosystem are a fundamental aspect of city design); and (3) Integrating research and practice through design (recognising the pedagogic cycle of research, practice and education and unifying application through design, including the comparative value of precedent).

These three meta-principles provide an integrated basis for practice and help express pre-conditions for purposed intervention in the city and in the creation of new contexts.

The empirical evidence and enquiry described in the publications demonstrates the opportunity for an integrated method for studying and practicing design-based urbanism. Its implementation has demonstrated impact through: recognition in national and international awards; winning international competitions; and the adoption and dissemination of findings as policy by cities and national agencies. In turn this has guided investment in work on the ground and been used by public authorities to evaluate the design quality of proposed development.

The work has provided intellectual support for a new national academy (the Academy of Urbanism) and underpinned the policy base of the United Nations Economic Commission for Europe in its contribution to the 'New Urban Agenda'. In so doing, the work has established a number of propositions concerning urbanism in the 21st century: firstly, there is a pronounced trend to urban concentration in clusters of successful cities in the developed north, expressed as 'super-cities'; secondly that the renewed attention to ecology in response to environmental risk and climate change has brought about a new aesthetic in landscape design expressed as 'ecophilic'; and thirdly that trends in urban development can create urban entropy (e.g. urban sprawl, urban shrinking, urban concentration) or can, through intervention, create urbanity (e.g. the compact city, the resilient city).

THE CRITICAL SYNTHESIS

Introduction and Methodology


Urbanism is the pursuit of urbanity (PP01). The work described in this critical synthesis contends that urbanity at the start of the 21st century can, in large part, be pursued by design through the application of three meta-principles: (1) learning from place; (2) designing with nature; and (3) integrating research and practice through design. This narrative links together a number of key publications and other research outputs to this end.

The overarching aim underlying the submitted work concerns the (re-) introduction of design methods and practice into urbanism. Research questions have included: (1) Can methods be curated to achieve this? (2) What are the components of such methods? (3) Is it possible to test these in practice through research-by-design? (4) What can be learned from practical application and refinement? (5) What has been achieved by employing the methods? (6) What trends have been evidenced over the period of study? (7) What has been the contribution of the work in Scotland and internationally? These questions are graduated. The work began with questions (1) – (4) and was expanded in time to address (5) – (7). The work submitted here represents a learning journey – a systematic enquiry by design.

The research underpinning this narrative is longitudinal: the publications, research and practice extend over a period of 25 years from 1991 until the present; and it is situational and scalar: the work has been undertaken in different contexts and across different scales. These situational contexts extend from the singular designed artifact (a public space) through to cityregional planning. The work has therefore been applied and tested over time, within the contexts and across the scales at which the urbanist commonly engages.

The research method employed has been one of establishing propositions about urbanism and researching these through practice. The practice-based research is evidenced in the case studies documented in the publications. In this respect the content and method of the research follows a familiar pathway. However the work is also action oriented and documented through research-by-design.³ At regular intervals, reflective works were prepared and submitted for peer review and published in journal or book form.

The work is iterative: the sequence of developing propositions, testing these in practice followed by publication of synthesis has been completed on a number of cycles within the timeframe of the research and within the situational contexts. In this way the propositions, principles, methods and tools referred to in this text have been reviewed and updated and their




Figure 1a (above): The hierarchy of publications and outputs.

interrelationships have been refined through practice and reflected upon in the published work.

This narrative records the evolution of ideas, techniques and conclusions. It describes the point of departure, propositions derived from the literature, empirical evidence derived from case studies, synthesis into meta-principles, exposition in published work, lessons learned, impact from the work and key conclusions drawn.

Context

In the decades following World War Two, the cities of Western Europe and North America required extensive development to meet four needs: reconstruction of war-damaged cities (in Europe); reorientation of the economy to peacetime requirements; housing for returning servicemen and women; and, economic growth brought about by increasing post-war prosperity. In general, governments and industry deployed the theories and principles of modernism to bring about these changes.⁴ This practice was replicated in Eastern Europe and the Soviet Union.⁵ These methods had the benefits of a systemic approach and, as a consequence, were readily replicable, quick and relatively inexpensive when compared to traditional forms of development and construction.⁶

By the 1960s, however, there was disquiet over this approach – in particular the loss of heritage and community as traditional neighborhoods were 'comprehensively redeveloped'. The most effective criticism came through concern about the loss of heritage and the need for conservation. This in turn stimulated research and commentary seeking to rediscover values for the city to explain the traditions that had influenced its evolution as an ideal and as a developed reality. The 1960s saw the publication of five seminal works that laid the foundation for a paradigm change in urban thought and design (Lynch, 1960; Jacobs, 1961; Cullen, 1961; Bacon, 1967; and McHarg, 1969).

Lynch drew on techniques of cognitive mapping to develop techniques for explaining how people navigate the city; Jacobs concentrated on 'liveability' and use; Cullen on the aesthetic appreciation of place through techniques of serial vision; Bacon considered historical development from first principles to explain the evolution of cities; and McHarg brought ecology and sensitivity to the natural environment into urban thinking. Together, these works have had a lasting impact inspiring writing and practice by many. ¹⁰ Each has given rise to a school of thought but none by itself is complete as an approach to urbanism by design. The ideas and techniques need to be brought together and balanced in order to establish coherent and integrated methods. This work provided the foundation for the practice described in the supporting publications and in the body of work at Annex 06. Enquiry into the search for balance and integration is evidenced in the principal publications (in particular PP03–PP05 & PP10–PP14).

The paradigm change from the 1960s, 70s and 80s provided the intellectual foundation to re-engineer urban thinking and urban design and provided the stimulus for a re-appraisal of established ideals and techniques.¹¹ These changes in thinking provided the means to mediate the worst excesses of modernism while retaining important elements such as movement and

accessibility in the city begun with 'Traffic in Towns' and essential as cities increasingly become the home to the majority of the world's population (PP25).¹²

There is an extensive literature and research on this subject (Annex04 Bibliography). In this meta-thesis and the work that supports it, however, emphasis is placed on how, in addition to re-examining city building conceptually, it is possible to establish tools and methods whereby this understanding may be translated into practice to re-purpose the processes of urbanism.¹³ The evidence developed and the published work described is concerned with reflective and considered intent – to move beyond understanding to 'making' in order to enhance the quality of place and the quality of life.¹⁴ This critical synthesis acknowledges the legacy of theory but concentrates on principles and methods to plan, design and make the city – whether by design tool, communication technique or planning process (PP04–PP06 & PP10).

A number of propositions were derived from the literature referred to above and in the bibliography: (1) The historical record – evolution of pattern and culture; (2) Structure, density and use; (3) Composition and communication of aesthetics of place and form; (4) Experiencing the city – navigation and legibility; (5) Sensitivity of the natural environment – climate and ecology; (6) Movement and accessibility; (7) The democracy of design or 'universal design'; and, (8) Working with people, for people.¹⁵

These propositions were used to inform methods for application and were brought to their current form through development in practice, testing in the studio and refinement in research for national agencies.¹⁶

The process of (city) design lies at the heart of the work submitted and has been the underlying driver for the practice described, the methods developed and the publications produced.¹⁷ In 'Reasoning the Landscape' (PP23), it is argued that whereas everyone thinks about what they are doing, those who 'write', those who 'make' and those who 'do', reason differently.¹⁸ In this context therefore, urbanity (PP01) is about 'making' and shaping the eight propositions into actionable techniques. In 'Emerging concepts of urban space design', Broadbent (1990) provided an insight into resolving the intent behind the various propositions by reflecting on empiricism (trust in human senses), rationalism (working from first principles) and pragmatism (methods known to work in practice).¹⁹ Broadbent therefore provided an intellectual direction for reconciling the intent behind the thinking of Jacobs, Lynch *et al* to provide a starting point for city design in practice. The eight propositions and the reconciliation of the thought processes behind them therefore represented the starting point for the empirical evidence from

case studies using methods identified in design literature including 'protocols', 'generators' and 'problem-solving'. 20

The eight propositions therefore provide a thematic direction for practice as a means to reconcile human experience, and explore first principles and workable solutions evidenced in the published work.

Building the evidence base – Design-based research through practice

From the early opportunities presented in practice (SP01–SP04), the intent was clear and has remained consistent throughout the body of work described here: whatever the governmental manifesto of the day and the policy base established to implement it, *interventions in the city require to be designed*. To put this into effect requires a rationale, an argument and method of design and communication.

The case studies discussed in the supporting publications are reviewed below in their situational contexts for two reasons: firstly this follows broadly the chronology of the work that arose from opportunities presented by practice; and, secondly, it enables the propositions to be tested over different scales.

UK Cities: Three examples have been selected from UK cities – Glasgow, Newcastle-upon-Tyne and Sheffield. In each case the focus of attention was the city centre. From the mid-1980s until the turn of the century, Glasgow played a leading role in the development of regeneration practice in the UK with notable achievements in social housing and an emerging ability to deliver major events.²¹ The challenge in the design work was to respond to the hollowing out of the city centre that had occurred during the 1960s, 70s and 80s. The response sought to build on the heritage-led regeneration that had already taken hold in the city and respond to the initiatives of the city authorities to address the twin imperatives of economic recovery and the radical improvement of the physical environment.²²

The team included the late Gordon Cullen and sought to work with the eight propositions to develop an understanding of place and a justification for investment in the physical environment. Techniques included figure-ground mapping, cognitive mapping (Lynch et al), and analysis derived from the insights of Jacobs as well as the serial vision of Cullen himself. The strategy was well received and used to inform the development of the Central Area Local Plan and the funding priorities of the Scottish Development Agency (SP01, SP02).²³ Urban design techniques based on the propositions were used to illustrate and build the investment case. This work was widely recognised as groundbreaking and became the recipient of a number of national and international awards (Annex 06).²⁴

Similar challenges were addressed in Grainger Town, Newcastle-upon-Tyne with design methods again utilsed to address policy and investment challenges to effect physical improvement. The work described in the publications (PP02, SP03) was a key component of the strategy adopted by the Board of the Grainger Town Partnership and Newcastle City and later

recognised with national and international awards.²⁵ The Glasgow and Newcastle case studies are described in PP02. The third example concerns a strategy for Sheffield City Centre adopted by the city in 2004 and used continuously as a policy instrument until the present that again has employed similar applications of the eight design propositions and the techniques they embody (SP05).

These three examples demonstrate the initial testing and refinement of the propositions and the techniques developed to implement these in practice. The enduring validity of these propositions and techniques is demonstrated by the longitudinal period over which the work was undertaken and the recognition and citation in national and international awards.²⁶ The method was employed in numerous studies and later in Moscow in 2012-2014 with similar effect (SP06, SP07 & SP10–SP13).

This first body of practice provided the basis and the opportunity to take the first steps in synthesis of what had been learned in the pursuit of the first four research questions outlined at the beginning. The first thematic exploration, 'Dear Green Place: a question of equilibrium' (PP03), is an essay published in the catalogue for the 18th International Trienalle of Milan in 1992 as the principal text supporting the UK pavilion and exhibition. The essay addresses the relationship of people and their urban environment within the context of the thinking and teaching of Professor Sir Patrick Geddes and suggests that he foresaw the preoccupations of the industrial and post-industrial ages.²⁷ The essay then examines the realities of Geddes' propositions through the efforts of the City of Glasgow (the 'Dear Green Place' of the title) in its search for a sustainable future through a number of key themes including: 'living in the city', 'greening the city' and 'fabric of the city', which are set within the overarching drivers of 'heritage' – in the sense of cultural as well as built – and 'context' – the post-war history of the city.

The conclusions (PP03) entitled 'towards equilibrium and balance' introduce the concept of urban decay (also expressed as urban entropy in PP01) and suggest that striking a balance between the forces of development and decay through processes of integrated thought is a necessary pre-condition for establishing a state of dynamic or sustainable equilibrium in a city. The essay advances a series of proto-principles to achieve a city that is international, productive, creative, communicative, liveable and 'good' and foresaw, although as yet implicitly, the paradigm shift from the 'industrial city' to the 'knowledge city' which is addressed in later publications in PP18/PP19 and in the UN publications (PP24/PP25).²⁸ ²⁹

Further publications continued the examination of Glasgow as a laboratory of practice in urbanism in more depth and in a wider context. In 'Reading the City' (PP04), Glasgow was examined in the context of place and the

'genius loci'. The essay set out to provide a working definition of these terms and to position the Glasgow work within the theoretical context established in the first part of this text – specifically the work of Lynch, Geddes and Norberg-Schultz – in helping to derive the methodological propositions expressed in this narrative. In this way, the essay sought to establish an explicit understanding between propositions and methods by reference to the Glasgow examples and began to consider the later research questions (5–7).³⁰ The essay proposes that the significance of place is ancient and transcendental and that a balance needs to be struck between the cultural and existential analysis of place and the physical and functional (technological) analysis and concludes that cognitive mapping remains valid for contemporary practice in urbanism in order to enhance understanding of the structure and form of the city and assist in the preparation of strategies for the design of public space.³¹

Small and medium-sized towns: Over a period of years from 1995 until the present, a series of strategies have been prepared for the future of small and medium sized towns in Scotland, elsewhere in the UK and more recently in Scandinavia using techniques based on the propositions described earlier (PP08–PP10). Small to medium sized towns and cities have provided the opportunity to investigate and validate above propositions and design methods at a smaller scale. An example of this scale of work is described in PP05 in respect of the Lincolnshire town of Scunthorpe.³²

This work in practice in small towns formed the basis of research undertaken for the Scottish Government dealing with expansion of towns and the regeneration of entire towns. This research was brought together and disseminated to the planning and development community in Scotland in publications issued by the Scottish Government.³³ The published work based on this research explores in more detail the principles and methods through which places are designed. In the case of PP06, the challenges of masterplanning are reviewed and in PP07 the masterplanning of town extensions is described. PP08 describes the research and stresses the importance of process and illustration in design based methodologies. PP09/PP10 review the situational context of small towns in Scotland and Sweden and consider scale as a factor in urbanism. PP10 also noted the increasing importance of involving the public in managed and 'hands-on' consultation exercises (charrettes).³⁴

Publications PP06–PP08 are derived from case studies described variously in SP01–SP05 and PP05 and describe the methods evolved in response to research questions (1) – (4) in respect of masterplanning, settlement extension and the 'whole' place.

Public Space: The method evolved for design strategies, frameworks and masterplans has been carried through to implementation of designs for public spaces on the ground. In this way, the designs for public space are considered a logical corollary of design strategies and frameworks following in a process from initial proposition through development of strategy to design ending in construction. In this way, the resultant public space may be considered to exhibit the intent of the propositions and the methods developed from them particularly consideration of historical development, sensitivity to context and the natural environment, and legibility and orientation by design. Public space designed with this intent through a series of checks and balances creates a 'whole space' that is intrinsically 'democratic'.³⁵ ³⁶ Design of the public space evidenced at PP11 sought to demonstrate and resolve research questions explicitly in the process of preparing a design in order to balance the intent of the propositions, the needs of users and requirements of stakeholders.

Scottish Enterprise commissioned research to document the best practice evidenced by these methods and commissioned 'Streets Ahead' to disseminate the research through guidance for those retained to design and deliver projects with public investment (PP12).³⁷ The approach described in this text, from strategy through framework to design on the ground, was also included in national guidance issued by the Scottish Government in 'Designing Places' in 2001 as the document to be used *primus inter pares* in designing for place.³⁸

Wider horizons: The opportunity to explore the wider context and regional scale came with the invitation to act as a judge on the international competition for the Randstad in the Netherlands.³⁹ The essay 'City with a Green Heart: lessons from Randstad Holland' (PP13) documented the competition as an example of research-by-design that in turn afforded the opportunity to examine the issues influencing polycentric regions by comparing and contrasting Central Scotland with the Randstad-Groene Hart region in the Netherlands.⁴⁰

The essay considers identity in the peri-urban interface of city and landscape and the means to strike an equitable balance between urban and rural, development pressures and limited natural resources. Three issues were identified: identity, urban edge and urban sprawl. The essay evoked Frank Walker's proposition that identity is forged in the relationship of 'zeitgeist' and the 'genius loci' (reprinted in PP21) and stressed the importance of regional planning and the opportunity to create a Central Scotland Plan that might depart from mono-centric, mono-sectoral processes of planning and the iniquities of short termism. ⁴¹ It called for a long-term holistic vision as a route to a sustainable future and the achievement of a shared balance between city and landscape with equity among those who inhabit the city

including dwellers on the periphery. The essay concluded that: (i) comparison and contrast between cities, regions and cultures is a valuable process in urbanism and informative for design; (ii) there is a need to consider design at a scale greater than the city itself; and (iii) it is vital to consider green space as an essential part of the process of urbanism – in effect concluding that *learning from place*, *designing with nature* and *integrating thought* are central to the consideration of the city-region.

International projects – designing a new context: The final examples from practice comprise a series of international case studies that bring together the insights and understanding developed in earlier work. Over a period of ten years, a range of urban design, landscape design and urbanism projects were undertaken in Scandinavia, the Russian Federation, the United Arab Emirates and the Peoples Republic of China (Annex 06). The documentation for several of these cases has included film and examples have been included in the submission (SP10–SP15). Film is a valuable medium to evidence the holistic application of propositions and techniques and to document the process explicitly for dissemination and for open access to practice-based research.

In the example documented at SP06 and SP10, the former President of the Russian Federation (Dimitri Medvedev) and the Mayor of Moscow (Sergei Sobyanin) elected to stage an international competition for the expansion of Moscow. This proved to be a remarkable example of research-by-design where ten international teams worked in a competitive and collegiate manner over a six-month period to deliver a regional plan, a metropolitan plan and the design for a new federal centre. The process of the competition is described in SP06.⁴²

The theme of urban edge explored in Scotland and the Netherlands in PP13 was revisited in 2013 in collaboration with Strelka of Moscow in research for the International Moscow Urban Forum (PP14 Archaeology of the Periphery). This comprehensive research developed the concept of a 'Superpark' to explore an integrated and holistic vision for the periphery of Moscow reflecting concepts from PP03 and PP13.⁴³

The tension between places for people in the industrial age and its legacy of impact on place and identity is a consistent theme of the published work. If some consensus and stability was reached on the cusp of the 21st century, the full extent of the digital age has exposed challenges as the century begins to mature. The 'smart city' exposes tensions between place and people and systems and globalisation that threatens to be as great as that between people and industrial processes. The publications 'Binary Winds' (PP15) and 'The Congruence of Place (PP16) explore these challenges concluding that every technological 'revolution' brings its own set of

challenges for the relationship between people and place.⁴⁴ In 'A city of continuing traditions' (PP17) it is argued that the findings described in the PP03 and PP04 remain a valid basis for addressing the challenges of the 'smart city' and 'big-data'.

Studio testing: In parallel with work in practice described in SP01–SP07 and SP10–SP15, the propositions and techniques were investigated in the pedagogy of the studio at masters level: in the Office of Urban Architecture at the Scott Sutherland School of Architecture at Robert Gordon University from 1989–2004 (PP06), at the School of Architecture, Chalmers University, Gothenburg, Sweden (SP08) and in the Glasgow Urban Laboratory in the Mackintosh School of Architecture, The Glasgow School of Art (PP18/PP19).

The body of work described in the principal and supporting publications (PP01-PP14 and SP01-SP15) evidences the investigation of the eight propositions in practice and supports a number of conclusions: the tools and techniques originally identified have proved sufficiently robust to endure over time and in differing contexts and they have proved flexible and able to adapt as their relative importance has changed to reflect society's demands. For example, it has remained valid to employ the techniques of cognitive mapping. However, the emerging importance of design methodologies for engaging the citizen and user groups has become more and more important over time. 45 Similarly, basic propositions around the natural environment have been and remain critically important. Indeed their relative importance has increased over time with the emerging significance of climate change and the impact this has on cities and their resilience to cope with these challenges.

The practice described in the supporting publications and cataloged at Annex 06 has been the laboratory for developing and testing methods for carrying out urbanism by design and the steps of synthesis this requires. From a starting point of the paradigm shift presented by emerging thinking in the 1960s and synthesis overtime, it may be concluded that whereas approaches based on empirical, rational and pragmatic thought are necessary for intervention in the city, none is by itself sufficient. The search for a comprehensive approach requires balance and integration where the weight afforded to different methods is contingent on the circumstances and the context. The empirical evidence documented in the publications has demonstrated that integrating thought and practice into a small number of overarching meta-principles provides unifying themes that can be expressed as:

 Learning from place – physical, cultural and human: combining the historical evolution of a place and the evolution of the culture;

- Designing with nature ensuring the aesthetics and ecology of the ecosystem are a fundamental aspect of city design;
- Integrating research and practice through design recognising the pedagogic cycle of research, practice and education and unifying application through design, including the comparative value of precedent.

These three meta-principles provide an integrated basis for practice and help express pre-conditions for purposed intervention in the city and in the creation of new contexts.⁴⁶




Figure 2: The methodology from PP08 reconfigured as an enquiry into 'learning from place'.

Giving purpose to the meta-principles: Reflections, trends and propositions

A number of the publications have now been discussed.⁴⁷ This penultimate section of the narrative considers the publications (PP20-PP25) that are more intentional and propositional in nature and have reflected on the later research questions (5–7).⁴⁸

This recent published work brings together a more comprehensive exposition of the meta-principles in three parts: in the establishment of the Academy of Urbanism, a new national academy (PP20–PP22); in the book 'Growing Awareness' (PP23); and in research for the United Nations, documenting trends in urbanism in the northern hemisphere (PP24/PP25).

The situational classification of the urban context has been essential to building the evidence base presented here. It provided the typological and intellectual basis for the Academy of Urbanism to consider urbanism in context through cities, towns, neighbourhoods, streets and places, together with the criteria by which these are evaluated.⁴⁹ The principle of learning from people and places together with learning from diverse precedents has been essential to reaching a view about the urbanity of a place that is embedded in the Academy's manifesto. The typology and the criteria provide an underlying rigour evidenced in the authorship and editorial of the first two of the Academy's anthologies published by Routledge as 'Space! Place! Life!' and 'Urban Identity', both subtitled 'learning from place'. (PP20/PP21). The thematic consideration of the city was also brought to the English-language version of the Academy's collaboration with the City of Freiburg published as the 'Freiburg Charter for Sustainable Urbanism' (PP22). These three publications represent the intellectual underpinning of the principal output of the Academy during its first five years and continue to support its work, activities and publications today.

This intentional and propositional thinking has been further advanced in 'Growing Awareness: how green consciousness can change places and perceptions', a paean to 'designing with nature' that brings together global thinkers and practitioners and contends that 'designing with nature' and its integration into mainstream thinking is essential to urbanism. This book revisits and expands on the ideas initially examined in PP13 concerning the interaction of urban edge and urban sprawl with ecosystems. The book concludes with ten summary principles in the chapter 'Towards a new paradigm in landscape and environment' and draws the specific conclusion that the changing narrative of the last 20 years has created a new paradigm in the aesthetics of landscape design expressed as the 'ecophilic' that adds to and complements the established aesthetics of landscape expressed in the 'sublime' and the 'picturesque'.

The final publications describe the consideration of cities for UN-Habitat (PP24/PP25).⁵⁰ The UN-Habitat report of research in the UNECE region (PP25) documents the transition from the 'industrial city' to the 'knowledge city' and identifies the importance of place in this paradigm shift. The report repurposes subtly some established UN shibboleths wherein the commodity of 'housing' is re-presented as 'living in cities'; the title 'economy of cities' is in deliberate deference to Jane Jacobs and 'environment' is subtitled with 'risk' to underline the importance of ecology to the resilience of the human habitat.

Urban sprawl and urban entropy figure prominently and the work substantiates the trend towards urban concentration in the global north also evidenced by others (e.g. Florida, 2010). The UN report reflects on the role of place and space in the 'knowledge city' introduced earlier (PP03, PP13 & PP14) and stresses the risk of urban sprawl and ecosystem fragmentation described in 'Growing Awareness' (PP23). In PP25, a distinction is drawn between mega-cities (essentially mono-centric and southern and eastern in the world context) and the patterns of urbanisation in the developed north. 'Super-cities' are defined as agglomerative economic regions formed of competitive and concentrated city clusters in North America and in Europe.

The key findings are expressed in the executive summary and accompanied by a series of diagrams proposing that trends in urban development can be expressed as cycles that can be destructive (urban sprawl, urban shrinking, urban concentration) or can, through intervention, be constructive (the compact city, the resilient city).⁵¹

Summative conclusions:

This critical synthesis is concerned with narrating an enquiry into design-based urbanism documented in a series of principal and supporting publications. It is a reflective review of a body of work assembled over two decades that sets out a coherent narrative of a body of work. It discerns patterns and a convergence of thought and intent around the three meta-principles brought about by self-directed enquiry, documentation and testing.

From the outset of the enquiry described herein, it was judged inadequate to implicitly accept and apply techniques in practice. Rather it is considered essential to understand the intellectual basis of practice that may be considered as urbanism by design, to understand the linkages between the spectrums of thought and to formulate, test and validate techniques in a systematic process of design-based practice and research.

A series of propositions were derived from the literature and used as a prospectus to unify the application of techniques to address the initial research questions (1 to 4) and thereafter to effect by intent positive change in the quality of places and the quality of life of citizens. The empirical evidence from a body of practice-based research is documented in the supporting publications (SP01–SP15). Principal publications (PP02–PP17) investigate and evidence this enquiry reaching its fruition as expressed in three meta-principles: (1) learning from place; (2) designing with nature; and (3) integrating research and practice through design.⁵²

The final series of principal publications (PP18-PP25) address research questions 5 to 7 and represent the published basis of the intellectual enquiry based on shaping and formulating these meta-principles, drawing conclusions and inferring propositions based on this enquiry.

Finally, in terms of contribution to knowledge and to impact, two overarching conclusions may be drawn.

(1) The body of work represented in the empirical evidence described in supporting publications and the first set of the principal publications (to PP17) has demonstrated the opportunity for employing integrated methods for studying and practising design-based urbanism. This work has demonstrated impact through: recognition in national and international awards; winning international competitions; and the adoption and dissemination of findings as policy by cities and national agencies. In turn, this has guided investment for implementation of work on the ground (e.g. St Andrew Square, Edinburgh PP11) and been used by public authorities to






Figure 3: The UK illustrated as a 'super-city' of around 60mio population as expressed in PP25.

evaluate the design quality of proposed development (Sheffield Urban Design Compendium SP05).

(2) The body of work in the later publications (PP18–PP25) has provided the intellectual support for a new national academy – the Academy of Urbanism – predicated on 'learning from place' and has underpinned the policy base of the United Nations Economic Commission for Europe in its contribution to the UN-Habitat 'New Urban Agenda'. In so doing, the work has established a number of propositions concerning urbanism in the 21st century: firstly, there is a pronounced trend to urban concentration in clusters of successful cities in the developed north, expressed as 'supercities'; secondly the renewed interest in ecology through enhanced awareness of environmental risk and climate change has brought about a new aesthetic paradigm in landscape design expressed here as 'ecophilic'; and thirdly that trends in urban development can create urban entropy (e.g. urban sprawl, urban shrinking, urban concentration) or can, through intervention, create urbanity (e.g. the compact city, the resilient city).

DECLARATION OF AUTHORSHIP

Much of the evidence underpinning the publications in this submission was assembled through collaborative work by teams of people. It is important to document clearly the working method and my role. At the outset, it is important to stress that, although I have shared the journey with partners and collaborators along the way, the coherence and structure of the body of published work has been curated by me alone. I have put in place and actioned the intent and discipline to achieve a number of goals: to structure, record, document and publish the work in the form presented; to purpose design practice to an intellectual as well as an aesthetic and practical end; and to explain, disseminate and give coherence to a body of design practice in urbanism. Latterly, I have sought to extend these aims to help explain and disseminate key trends and directions for the city in the 'global' (or developed) north at the beginning of the 21st century aided by the meta-principles identified through this submission.

With the project work that is written up in the supporting publications, I acted as the partner leading the Gillespies work. In respect of research objectives, I set the parameters for the work, made the questions underlying briefs explicit and reconciled these with best practice and intellectual enquiry. I framed the methodologies, established the techniques to be employed, briefed and edited content and acted as principal writer and editor of the finished documents – the role of principal investigator in research terminology.

In every case where the (supporting) publications document the projects with myself as sole author, the authorship is solely mine. In all the cases where I share authorship, I prepared the text and undertook the editorial of the final document.

This pertains where Gillespies, under my direction as partner, was sole or lead consultant. In the case of consortia projects where Gillespies were part of a larger team, a slightly different methodology pertains. In these instances (described in SP06/SP07 and SP10–SP15), I acted as director of Gillespies input and as co-creator (co-investigator) for the project as a whole. In the case of SP10–SP15, I have described my role as co-curator for the films produced. In these instances I shared the producer role with colleague partners in the other practices, storyboarding the script for the director who is named in each case as auteur.

With the principal publications that form the substantive part of this submission, I had sole authorship of the publications where I am listed as sole author (PP01–PP04, PP06, PP08–PP11, PP13–PP15 & PP20). In PP05 (and SP04), I authored a case study that was included in an anthology edited by others. Two of the principal publications (PP07 & PP12) have

Gillespies identified as author. In these cases I undertook the role described in the second paragraph above i.e. principal investigator.

In PP18 and PP19, I set the research questions, directed the studio and supervised the research undertake by a group of Part II architecture students as a research project within the Glasgow Urban Laboratory. In both instances I was assisted and supported by the Fulbright scholars attached to the Glasgow School of Art. The formal responsibility for the work was my own.

For PP16, I gave the conference presentation and was co-author. For PP17 and PP21, I was lead author, coordinator, and editor.

Finally, there are a number of publications where my role has been as one of research coordinator, editor and author of specific parts of the work.

With work for the Academy of Urbanism (PP20–PP22), I acted as principal editor of the two books published by Routledge (PP20 & PP21) and acted as author of individual chapters. With PP22, I was a part of a research team that brought the document together acting in a drafting and editorial capacity.

For 'Growing Awareness' (PP23), I approached the Central Scotland Green Network Trust to investigate, document, order and disseminate the evidence the organisation has collected over 5 years through their annual national conference in Scotland (the Green Network Forum). Working in partnership with my wife, we reviewed the material assembled, structured the work into three themes, briefed and edited the work of the 15 selected authors. The work was a partnership effort. It is necessary here, however, to identify my distinctive contribution. It was my responsibility to clarify from authors the intellectual and pedagogic elements of their work, to bring coherence to the whole and to set up the framework for the research in the first chapter and to draw it together in the final chapter under my authorship.

Finally, in the case of PP25 (UNECE Regional Report), I briefed a specialist input for chapter 4 (Rosenfeld), collaborated on chapters 5 and 6 (Küsters and Elisei), authored the remainder of the report and structured and edited the entire content. For PP24 (the journal article in 'disP'), I collaborated with the Acting Director (Keiner) and colleagues in the UNECE Division responsible on what is, in effect, a pre-publication executive summary of the report that was intended to disseminate the content in advance and stimulate consultation. Thereafter, I was responsible for collating comment on the report itself from member states, UN staff and from the academy to refine and obtain signoff on the final

document from the UNECE Committee of Housing and Land Management prior to Habitat III.

Letters from co-authors, collaborators and clients corroborating this statement of authorship have been submitted under separate cover to the Head of Research, the Glasgow School of Art.


